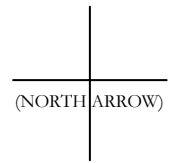

- ◆ This application must be completed in its entirety and returned to the City of Wooster Division of Engineering for authorization prior to making any water connection.
- ◆ Each building requires a separate water service with a separate permit. You must call the City Plumbing Inspector when the service is ready for inspection, at (330) 263-5253. Inspection must be made before covering any of the work.
- ◆ All fees must be paid with this application before making any water connection. See below for fees.
- ◆ If you are abandoning an existing well, you must also contact the Wayne County Health Department.
- ◆ See City of Wooster Ordinance 921.05 for additional water service connection requirements.
