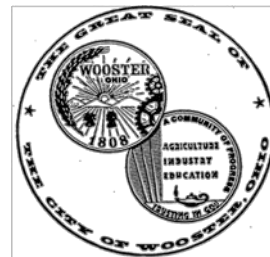

**REQUEST FOR AUTOMATIC EXTENSION OF TIME TO FILE**

**This extension does not extend the due date for any estimated taxes or tax due for 2020.**

1. I request an extension of time until \_\_\_\_\_, 2021 to file my City of Wooster income tax return for 2020.
2. The extended date requested should be no later than October 15, 2021.
3. No late filing penalty will be charged; however, penalty and interest shall be calculated on the amount remitted after May 17, 2021.

**DECLARATION OF 2021 WOOSTER INCOME TAX ESTIMATE**

**Due on or before April 15, 2021**

Extension of time to file a tax return does not apply to a declaration of estimated tax or payment of quarterly installments

The tax rate for 2021 is 1.5%. The City of Wooster allows 100% credit for taxes paid to another city up to 1.5%

5. A declaration of estimated tax should be filed, and quarterly estimates made for 2021, to avoid penalty and interest for any taxpayer required to pay 2021 estimated taxes. A taxpayer is required to pay estimated taxes if their tax liability, less credit for Wooster taxes withheld and/or taxes paid other cities, will equal or exceed \$200.

**2020 NON-RESIDENT INDIVIDUAL NON-FILING  
 DECLARATION Due on or before May 17, 2021**

Non-residents who received a Wooster income tax return in the mail or filed a 2019 tax return and are not required to file a 2020 Wooster tax return, should complete this non-filing declaration in lieu of filing a tax return.

I/we were not residents of Wooster at any time in 2020, any wages earned within the City of Wooster had Wooster income tax withheld at a rate of 1.5% or greater, and I/we had no business or rental activity within Wooster in 2020.
