REQUEST FOR EXTENSION OF TIME TO FILE

This extension does not extend the due date for tax due for 2024 or any estimated taxes for 2025.

1. I request an extension of time until _____, 2025 to file my City of Wooster income tax return for 2024.
2. The extended date requested should be no later than October 15, 2025.
3. No late filing penalty will be charged; however, penalty and interest shall be calculated on any amount due.

DECLARATION OF 2025 WOOSTER INCOME TAX ESTIMATE

Due on or before April 15, 2025

Extension of time to file a tax return does not apply to a declaration of estimated tax or payment of quarterly installments

The tax rate for 2025 is 1.5%. The City of Wooster allows 100% credit for taxes paid to another city up to 1.5%

5. A declaration of estimated tax should be filed, and quarterly estimates made for 2025 to avoid penalty and interest for any taxpayer required to pay 2025 estimated taxes. A taxpayer is required to pay estimated taxes if their tax liability, less credit for Wooster taxes withheld and/or taxes paid other cities, will equal or exceed \$200.
